GUIDELINES FOR ICSE YEAR 2025-RECHECK & RE-EVALUATION

Enquiries concerning examination results, behalf of the school candidates must be made to the Chief Executive and Secretary of CISCE only by the Head of the School concerned and must reach the CISCE's office, not later than the specified date. Enquiries should be restricted only to results which are significantly below the standard suggested by the candidate's school work in the Subject/Paper.

1. Recheck: The accuracy of marks awarded in a Subject/Paper will be checked on request, in one or more Subject/Paper(s), provided that the Head of the school/candidate submits the application online. Applications for Recheck must be submitted on-line and must be received by CISCE not later than FOUR days from the day of the declaration of results, which is not later than 4th May 2025. For Recheck, candidates will be required to pay on-line a fee of Rs.1,000/- per Subject/Paper.

The Recheck will be restricted only to check whether:

- all the answers have been marked.
- there has been a mistake in the totalling of marks for each question in the subject/pa per and in transferring the marks correctly onto the cover page of the answer script
- the continuation sheets attached to the answer script, as mentioned by the candidate, are intact.
- (i) The recheck will be carried out by a competent person appointed by the Chief Executive and Secretary of CISCE.
- (ii) On rechecking the scripts, if it is found that there is an error, the marks will be revised accordingly.
- (iii) The results of all the recheck requests received by CISCE will be declared together on the website of CISCE (www.cisce.org).

The candidates who are not satisfied with their Recheck results in the Subject/Paper(s) for which they had applied, will be permitted to apply for Re-evaluation of their answer scripts of those Subject/Paper(s) only.

2. Re-evaluation: The accuracy of a subject grade awarded will be checked on request, in one or more Subject/Paper(s), provided the Head of the school/candidate submits the application on line. Applications for Re-evaluation must be submitted on line and received by CJSCE within THREE days from the date of declaration of the Recheck Results. The date of declaration of Recheck Results will be notified to all the stakeholders, through the website of CISCE (www.cisce.org).

For each Re-evaluation, candidates will be required to pay a fee Rs. 1,500/- per Subject/Pa per, which shall be made online.

The charges paid for Re-evaluation of answer scripts will be non-refundable.

The results of the all the Re-evaluation requests received by CISCE will be declared together, on the website of CISCE (www.cisce.org).

- (i) The re-evaluation of answer scripts will be carried out by a competent person appointed by the Chief Executive and Secretary of CJSCE.
- (ii) On re-evaluation of the answer scripts by the subject expert, the marks awarded, whether increased or decreased, will be considered as the FINAL marks.

Important Points:

- (i) No candidate, person or organization shall be entitled to claim disclosure or inspection of the answer scripts or copies of it and other documents as these are treated as most confidential by CISCE.
- (ii) CISCE will not be responsible for any loss or damage, or any inconvenience caused to the candidate, consequent to the revision of marks and no claims in this regard shall be entertained.
- (iii) The Result documents for the candidates who have applied for Recheck/ Re-evaluation, will be released after the result of Re-evaluation is declared.
- (iv) The result of the Recheck/Re-evaluation will be available on Digi-Locker as well.

The decision of the Chief Executive & Secretary of CJSCE on the result of the Re-check & Re-evaluation shall be final.
